Hopkinton Center for the Arts Spring Arts Festival is a regional celebration of Arts for crafters, artists, musicians, performers and community members to come together to enjoy the arts.

Selection Process: The HCA seeks area artists and crafters to show and sell original artwork such as paintings, sculptures, collage, hand-made pottery, jewelry, wooden crafts, home furnishings, stained glass, metalwork, candles, soaps, doll clothes, pet supplies, hair accessories, baked goods, etc will be considered. Selections are made on the basis of originality, craftsmanship, artistic conception and professional presentation. Artwork and entertainment must be appropriate for family viewing. Performances will reflect the diversity and talent of our community members. A variety of styles and genres will be selected.

Artists and crafters are required to provide 3-5 digital images of their work with measurements and a booth display photo with their application and a self addressed stamped envelope if they wish them returned. The works for intended exhibition must be represented accurately in submission materials. There will be a limited number of indoor vendor spaces available. Apply early as these will fill up fast.

Information, Rules and Regulations:

- ❖ Application Deadline: March 5, 2012. Vendors will be notified within one week from the date of application or by March 12, 2012
- ❖ Rain Date: Sunday May 6, 2012
- ❖ Indoor display spaces 6'X8' \$60. Outdoor spaces 10'X10' \$65. 10'X15' \$80.
- ❖ Full payment (non-refundable) must be received with application.
- ❖ All food vendors must apply for and obtain a temporary permit from the Hopkinton Board of Health
- ❖ Earliest set up at 8:00 am, registration by 9:30am and be all set up by 10:30 am
- ❖ All items for sale must be made by the seller, no resale or imports
- ❖ All vehicles must be moved after set up to the H.H.S. parking lot
- ❖ Most exhibitors are located outdoors and should plan accordingly
- ❖ Artists must supply their own tables, chairs, table covers and display racks
- ❖ All tables must be covered to the floor/ ground and all packing materials stored underneath out of sight
- ❖ Booth spaces are non-transferable and cannot be divided
- ❖ No electric hook ups provided
- ❖ Exhibitors must be on-site for the entire festival, no early breakdown
- ❖ All canopies must be weighted down to prevent wind blow over
- ❖ Exhibitors must leave their area free of trash and debris
- ❖ Exhibitors are responsible for collecting and paying MA sales tax
- ❖ Spaces must be clean and vacated by 7:00 pm
